WHAT YOU NEED TO KNOW

Join The Sandwich Baron Club today and you will get point's equivalent to 2.5% on your entire bill excluding VAT.

You will be able to cash in your points at any store at any time.

Club members will be notified of all promotions and offers.

Apply on line at www.sandwichbaron.co.za and you will be allocated a Club membership number within 48 hours or apply in store and receive your card immediately.

Your personal information will not be provided to any third party.

Hand us your Sandwich Baron Club card when placing your order or if you have had food delivered write down your 15-digit code on your bill and send it back with our driver.

Your 2.5% of the total bill excluding VAT in points will be loaded to your card within 48 hours.

Points cannot be exchanged for cash.

TERMS AND CONDITIONS

Sandwich Baron can at any time terminate or suspend the loyalty program by giving you three month's notice. Such notice will be recorded on our website and the notice will apply from the date it appears on our website.

Terms and conditions can be changed without prior notice and will be binding on the card holder. Any change will be recorded on our website.

We reserve the right to terminate or suspend your membership without notice.

Points cannot be redeemed for cash.

Your Sandwich Baron Club card is not transferrable.

Your Sandwich Baron Club card cannot be used for company orders and is for use by natural persons.

Your Club membership is not transferable.

The Club Card or 10-digit membership number can only be used on the day of purchase.

A lost card fee of R30.00 will be charged for the replacement.

Your card can only be used subject to these terms and conditions.

No employees of Sandwich Baron may apply for membership.

Any dispute in relation to any aspect of the program will be determined by any director of Sandwich Baron Franchising, or his nominee, whose decision will be final and binding and no correspondence will be entered into.

Club members may not cede any rights or benefits obtained by virtue of their participation in the program.

Club members shall have no claims whatsoever against Sandwich Baron Franchising (or any of its franchisees) for any losses or damages incurred as a result of their participation in the program.

Cards that are inactive for a period of 6 months may be deactivated and can be only activated by emailing loyalty@sandwichbaron.com

By accepting these terms and conditions members of the program expressly consent to the transmission of any of their personal data (including but not limited to the name of the Club member, any identifying number, symbol, email address, physical address, telephone number, location information, online identifier or other particular assignment) to the third party supplier who manages the program and database on behalf of Sandwich Baron.

The third party supplier operates their secure and encrypted database within the Republic of South Africa.

Sandwich Baron and its third party supplier undertakes to comply all laws, policies, and procedures relating to the protection, storage, handling, privacy, processing and retention of data as well as the destruction of data, including personal data.

Sandwich Baron and its third party supplier shall ensure that it processes data for only the express purpose for which it was obtained.

Members of the Club may terminate their membership at any time and on receipt of such notice of termination Sandwich Baron and its third party supplier undertake that personal data will be

destroyed to an extent that it cannot be reconstructed to its original form subject to any legal retention requirements.

Sandwich Baron shall ensure that it does not disclose personal data of recipients of the Sandwich Baron Club Card, other than in terms of this terms and conditions.

Sandwich Baron undertakes to ensure that it has all reasonable technical and organizational measures in place to protect the personal data from unauthorized access and/or use;

ENTIRE AGREEMENT
